RESEARCH

Raised money to fund grants for scientific and medical research to assist in finding a cure for NBIA. In 2010, \$179,664 was raised for research and two grants totaling \$85,933 were awarded: a \$30,000 research study grant to Drs. Timmerman and Pauls at the University of Cologne (Germany); and \$55,933 in bridge funding to the Hayflick lab at the Oregon Health & Science University. Our Scientific and Medical Advisory Board evaluates grant proposals and makes recommendations to the Board of Trustees, and also advises the Trustees on medical matters.

The Association publishes a free newsletter, three times per year, which is sent to over 4200 subscribers. The newsletter promotes awareness of NBIA, educates the public and medical community about NBIA, supports affected families, and disseminates information on NBIA research and treatment.
